

INTRODUCTION

Fire is one of the most destractive manmade disasters of all time. Fires have become increasingly lite threatening hazards, because within a few minutes it can kill and destroy. Fire disaster is a serious threat to the functionality of the built environment in densely populated areas and can severly damage different intrastructures. Markets have been one of the most vulnerable sections of the urban areas to fire disaster.

Market of Fulia are considered the most vulnerable areas where fire frequently breaks out. The market is constructed with wood, plywood, bamboo, plastics, all of which are highly combustible substances. Most of them store gas cylinder. Illegal looking from electric poets is also rampant in these market. All these add to their vulnerability to catch fires.

PROBLEMS ARISING DUE TO FIRE ACCIDENT:

This section discusses and presents the impacts of the fire disasters on the environment of markets of Fulia.

- i. **Environmental Damage:** The Fire spread through the market and burnt down one big trees, therefore the creatures who lived on those trees were also fail into the range of Fire.
- ii. Create Pollution: After the terrible Fire incident there were song harmful gas like CO₂, NO, CFC, SO₂ etc added in the air. But also the some was because a temporary deadlock situation to the adjacent market area.
- **iii. Economic Crisis:** Due to fire the shops which were totally burnt down those shop owners faced a huge financial crisis. Their livelihood becomes uncertain. Around 10 shops owners suffered a loss of Rs. 3 to 4 Lakhs.
- iv. Create Panic: The terrible fire incident was created a trauma in the mine of the adjacent market area peoples. Although many have overcome that fear, many still have that impression.
- v. Neither Government Help nor Having Insurance: After this Fire, any financial help was received from the government to restore the damaged shops to hire previous condition. As a result, it becomes impossible for the shop owner to start a new business and some of them have no other no other way to continue their some business. Also the owners of any fire damaged shop are in financial trouble as they are not insured.

SUGGESTION AND RECOMMENDATIONS:

- i. Use non-combustible type building material to build the shop.
- ii. Sufficient space around the perimeter of the building for easy access and money variability of fire service vehicles shall be maintained.
- iii. Don't store LPG cylinders in the market area.
- iv. Don't hook from electric post.
- v. There should be at least 2 meter gap between two houses.
 vi. Inform Fire Brigade either 101 or special telephone No. of local Fire station and be assumed that the information received by the Fire Brigade by the local fire brigade.
- vii. Keep ready the fire extinguishing arrange market.
- viii. Keep ready at least one ambulance in every market.
- ix. Keep fire away from tarpaulin or other flammable fund.
 x. Managing committee must allocate adequate fund.
